### *Public*

Carol Ertle thanked the Recreation Commission for their help with the spring soccer program.

He reported that the scheduling problems for the eight teams were addressed. S. Patamia stated that we need to watch that the normal spring sports are not impacted. Discussion followed.

### *Chairman/Director's Reports:*

#### C. Johnson:

Distributed corrected Rules and Regulations which were reviewed by the town's attorney.

Suggested requiring Birth Certificates for proof of age for the Park registration.

Signs to close the fields when conditions are bad are on order.

She is getting the netting for the first baseline on the small field at Donatoni Park.

Presented the list of summer employees (see attached).

Reported that John Mirabella requested use of Donatoni Field for the Legion Baseball team. There are 6-7 boys from Rockaway Borough on the team. He will submit the proper Use of Facility Request Form.

The playground set for the lake will be in by the middle of June.

She will order portable scoreboards.

The Police Department reported there was graffiti in the park. It has been cleaned up.

#### S. Patamia reported:

Thanks to everyone who helped, the dedication of Donatoni Community Park was great.

She will get a gift certificate for the Department of Public Works men to have lunch.

When people request to use Donatoni Field and there is less than 50% of Rockaway Borough residents involved, a fee should be charged for using the lights. C. Johnson said the lights cost \$10.00 per hour to operate. She suggested charging \$25.00 per hour. R. Seifert suggested surveying other towns. Discussion followed.

### *Old Business:*

R. Seifert suggested a "No fishing from the docks" sign and permanent gates with locks be installed at the lake. S. Patamia said she will look into it.

*New Business:*

S. Patamia asked for a motion to charge a fee of \$25.00 per hour for use of Donatoni Field with lights if less than 50% of the people involved are Rockaway Borough residents. A motion was made by R. Seifert and seconded by T. Haynes. All in favor.

S. Patamia asked for a motion to accept the Recreation Commission Rules and Regulations as presented. A motion was made by R. Seifert and seconded by T. Dennehy. All in favor.

S. Patamia asked for a motion to accept the list of summer employees (see attached). A motion was made by T. Mulligan and seconded by T. Dennehy. All in favor.

S. Patamia asked for a motion to accept the Use of Facility Request Form from Rushmore Soccer to use Friendship Field on July 10-14, 2006, provided that the program is for Rockaway Borough children and that a roster with ages be submitted. A motion was made by T. Haynes and seconded by T. Mulligan. All in favor.

The letter from Henry O. Baker was discussed. C. Johnson suggested advising Football to obtain the necessary General Liability Insurance.

S. Patamia said the Use of Facility Request Form from John Mirabella (Legion Baseball) will be submitted by May 24<sup>th</sup>. She requested a motion to allow the team to use Donatoni Field on the dates stated with a \$25.00 per date fee. A motion was made by R. Seifert and seconded by T. Mulligan. All in favor.

S. Patamia suggested inviting the Activity Presidents to next month's meeting. They will be introduced to their Recreation Commission Liaison and advised that everything must be in order before they may take the field. Liaisons are needed for track, swimming, skiing and tennis.

*Commissioner's Reports:*

Haynes reported:

- Jr. Knights Wrestling held their elections. All three coaches are from Rockaway Borough.
- The Football social will be held at the Rockaway Borough American Legion.

T. Mulligan reported:

- Due to the snack stand situation and parking problems, the Mayor's Trophy game will probably not be held at Donatoni Field. It will be held in Wharton.
