J. Mirabella:

- Discussed the bids for Friendship Field
- Reported that Joe List will be ready to install the pavers at Donatoni Park by the end of the week.
- He received three quotes on installing a new large electrical box in the

concession stand. The small items are ready to run.

- The partitions for the museum should be here this week and installed next week.
- In three weeks, the concession stand and museum should be operational.
- Discussed the football field at Donatoni Park.
- He would like to raise money for a playground.

• Reported that there is a Fall Baseball team (ages 15-17) that would like to use Donatoni Field. Discussion followed. C. Johnson and S. Patamia said the players would have to get Recreation Cards. (\$60 for out-of-town players).
